- Owners - Owners are people that have this equipment in their business and have read and fully understood this whole user manual. The owner is responsible for ensuring that any other person who uses this equipment has also read and understood this user manual and labeling on the equipment.
- Operator/User - People who are responsible for the operation, cleaning as well as general maintenance care, as outlined in this manual, and who instruct the patients in the operation of the equipment. All operators have fully read and understood this user manual and labeling on the equipment.
- Patient - Any person that receives the tanning session.
- Service technicians- Certified technicians who will perform assembly and maintenance work on the equipment and have fully read and understood the user manual and labeling on the equipment.

All people that will be operating this equipment need to fully read and understand these instructions and all labeling on the equipment. A copy of the user manual should be readily available. This manual may include features that are not included for your bed. Any service work outside of the preventative care table in this manual should be done by a ProSun authorized technician.

This is a Class I ME Equipment, with Type B Applied Parts used for continuous use for a maximum of 10 minutes. The equipment is not intended to be sterilized or for use in an oxygen rich environment.



Preparing the Product for Use

ProSun does not assume any liability if there is non-compliance outside of the intended sale territories of the United States or Canada. The exporter assumes their own risk by removing this equipment outside of the United States or Canada.

Transportation:



Equipment must be transported on the pallet on which it is mounted, and should not be double stacked with other transport materials. If a forklift is used the long forks should be used and only from the correct side. Only lift the load a few centimeters and move it to the place of installation.

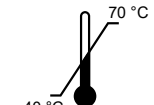
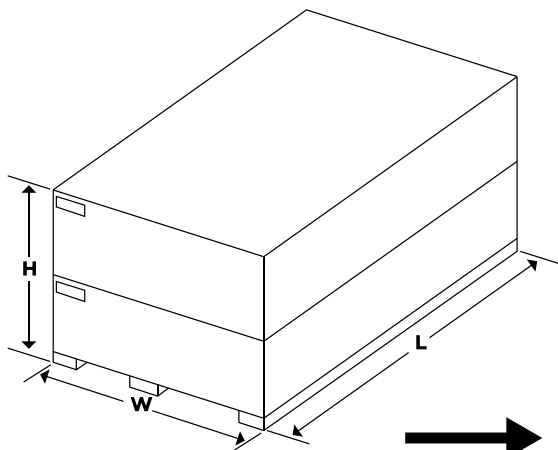


CAUTION - If the short forks are used damage may occur.

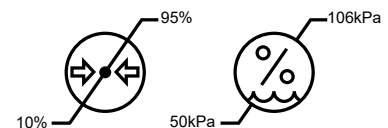
If a forklift cannot be used then the device must be partially disassembled from the pallet for transport. Installers or persons transporting the equipment may want to use a dolly to move the disassembled components but be careful of the weight. Each piece should be moved individually to the place of installation.

During transportation environmental conditions must be met, ambient an ambient temperature range of - 40 °C to + 70 °C or -40°F to 158°F, relative humidity range of between 10 to 95% including condensation and atmospheric pressure range of 50 kPa to 106 kPa.

If ambient temperature change is different from required temperature then let equipment sit at proper temperature for at least 2 hours prior to installation.

Delivery:

Once equipment is delivered make sure proper temperatures, humidity and atmospheric pressure are in place.

The following items are included in the delivery:

- Tanning equipment
- Protective goggles
- Tanning bed cleaner
- All parts in assembly manual
- User Manual



Note that equipment is delivered through third party freight company. Equipment will not be brought inside the building by freight company unless prior arrangements are made. Coordinate with ProSun installation department to set up delivery and installation details.

In a commercial setting an external timer is required. ProSun recommends to use this accessory (T-Max Flushmount G2).

Ventilation:



The Device must always have proper ventilation. Failure to do so can cause in serious safety hazards and overheating of the equipment.

Installation and Set-up:

Equipment should only be installed in dry rooms with proper ventilation and airing. The room should be the recommended size of 9 x 9 ft in order to allow for good air flow.

The unit should not be set up in a mobile environment or facility, i.e. trains, buses, ships. The unit also should not be used outdoors, if used outdoors damage to the equipment is possible and the manufacturer will not be held liable

Before starting the installation process or operating the equipment the transportation pallet should be removed. Observe correct room sizes prior to installation the equipment and ensure that room has correct electrical specifications. The customer must have provided a dedicated power source when called for in the technical specifications of the unit.

Environmental conditions for transport and storage:

- Relative humidity range of 10% to 95% including condensation.
- Atmospheric pressure range of 50kPa to 106 kPa.
- Storage temperature range: -40 °F (-40 °C) and 158 °F (70 °C)
- Let equipment sit for at least 2 hours if range was outside of ambient temperature

Environmental conditions for operation:

- Relative humidity range of 30% to 75% including condensation.
- Atmospheric pressure range of 50kPa to 106 kPa.
- Optimum ambient temperature range: 50°F (10°C) and 86 °F (30°C)



DANGER!

Installation can present a Danger with electrical shock or burns, only authorized personnel should install the equipment. Initial installation should be done by a ProSun certified technician. As the equipment owner it is your responsibility to ensure that correct electrical requirements are met and followed.

Overheating can occur if proper ventilation is not followed. Never obstruct the airways in the inflow and outflow areas. If proper ventilation is not followed system malfunction and damage may occur. Always install the unit at proper distance from walls in order to have proper airflow. Failure to do so may cause system failures or errors.

The customer is responsible for all costs associated with the preparation of the installation of the equipment. This includes but is not limited to room preparation, costs, fees, permits, and inspections unless specified otherwise in the sales order for the equipment purchased. ProSun and all authorized parties shall reserve the right to refuse to install equipment into any room which has not been properly prepared in accordance with the electrical specification and room requirements.

The electrical contractor or his designee shall provide and install all electrical material as specified for a safe operating system. ProSun certified technicians will not perform any electrical work. The recommended electrical plan must be coordinated between the customer and the electrical contractor. Any deviation of the electrical, before, during and after equipment installation is the responsibility of the customer. The electrical contractor or his designee shall ensure the completion of all electrical requirements prior to the installation of any ProSun equipment. All wires shall be single solid runs without splices, meeting NEMA standards. The electrical contractor or his designee should ring out, tag and terminate all wires at both ends. Each should be inspected to ensure that no wires have been grounded or are left open. ProSun certified technicians are not responsible for the final installation of the electrical system, the electrical contractor or his designee should be present to make the final electrical connection upon completion of the installation of the equipment.

The customer shall bear the sole responsibility for compliance with all applicable codes, OSHA, NEMA, local and national Standards. All electrical work shall conform to the requirements of the national electrical code, OSHA or applicable local and or state ordinances.

Commissioning of the tanning equipment

The equipment is initially commissioned by a certified ProSun technician. The device will be properly assembled and handed over ready for use. In order to properly commission the tanning equipment, the business owner must ensure that the location is ready prior to the equipment being installed. This included having correct power requirements and having the room in which the unit will be located ready.

The unit incorporates special preventive measures with regard to the electromagnetic compatibility and must be installed and commissioned according to the EMC instructions obtained from the assembly instructions.

If the equipment has not been used for a longer period of time, then it must first be inspected by a certified technician before being put back into operation again.



General Safety Information

General Safety Notes:

Any adult with any of the below issues should not use this tanning equipment. If you are unsure consult your doctor prior to use.

Contraindication: This sunlamp product is contraindicated for use on persons under the age of 18 years.

Contraindication: This sunlamp product must not be used if skin lesions or open wounds are present.

Contraindication: This sunlamp product should not be used on individuals who have had skin cancer or have a family history of skin cancer. People repeatedly exposed to ultraviolet sunlamp products should be regularly evaluated for skin cancer.

Contraindication: People with Skin Type I, who are prone to sunburn should not use this equipment, or had several severe sunburns as a child. People who are already suffering from sunburn should not use this equipment until the sunburn is completely gone and they can properly evaluate skin type and calculate their exposure schedule.

Contraindication: People taking photosensitive medications, medicines, or people who are being treated by a doctor for conditions related to photosensitivity.

Contraindication: People who wear a heart pacemaker.

Contraindication: People who are prone to freckles, or people with naturally red hair color.

Contraindication: People who have atypical discolored skin areas and/or with more than five atypical moles with a diameter of 5 millimeters. People with more than 16 moles with a diameter greater than or equal to 2 millimeters. If you are unsure consult your doctor prior to your tanning session.

Contraindication: People who do not tan at all or cannot tan without getting a sunburn.

Limits of Application:

Never operate this unit when the ambient room air temperature is greater than 104 degrees Fahrenheit.



WARNING!

Never operate this unit in a commercial setting when the remote timer is not working properly.

Always disconnect the unit from its power supply when servicing or repairing the unit.



WARNING!

Allow at least 48 hours to pass between each tanning session. Tan based on the exposure sticker on the unit or in this manual. Skin Type I should not tan. As an owner you must properly instruct all users on using the exposure table located on the front of the bed and only tanning for the minutes based on their skin type. If any negative effect occurs, stop using the equipment and consult a physician.

If you are taking any kind of medication make sure to first consult your doctor before tanning. Certain ingredients in medication can induce UV light sensitivity and cause allergic reactions. A table describing a number of known allergens can be seen later in this manual.

For best facial tanning results make sure to remove all facial cosmetics thoroughly prior to each session. Best results may occur if no cosmetics are used 3 hours or even the day of the tanning session. If certain cosmetics are used you may experience a UV light sensitivity that could cause an allergic reaction. See the table in this manual describing a number of known allergens later in this manual.

Do not use tanning lotions, oils or gels that contain SPF (sun protection factor) as these could hinder the desired tanning effect and may not have the same protection with tanning equipment as with natural sunlight. Use only those that are specifically manufactured for use in tanning beds.

If your skin develops or displays any sort of undesired reaction such as a rash, acne, or unusual dryness you should stop tanning immediately and consult your doctor.

Always avoid sunburn. If you overexpose yourself you could get a sunburn on your skin. Should this occur, stop tanning and wait for the reddish color to subside before recalculating your exposure schedule and resuming treatment.

Read the WARNING and DANGER label situated in full view of the user on the tanning bed before beginning your tanning session.

Never use tanning accelerator pills in conjunction with your tanning treatment as these could lead to an increase of skin sensitivity and sunburn.

Always wear protective eye wear.

Only (1) one tanner per session is allowed in the equipment.

The manufacturer cannot be held liable for damages or injuries from improper use of the equipment or non-observance of the operating instructions.



This tanning bed is an over the counter tanning device that emits ultra violet light in the UVB and UVA region of the spectrum intended for the cosmetic tanning of the human skin in adults.

Only one user should tan in the unit at a time.

Wear protective eyewear during the duration of the session to protect the eyes against UV radiation. Only use approved protective eyewear. Using the equipment without protective eyewear may in eye injury or diseases. The unprotected eye can become inflamed on the surface, and in certain cases the retina can be damaged by excessive radiation. Cataracts can form after repeated exposure to radiation.

You should not modify your equipment as it may cause serious injury or damage to your unit.

Infections can be transferred through skin contact, the unit should be properly cleaned after every use. All items that the user can come in contact with shall be properly cleaned and disinfected after every session. This includes but is not limited to:

- Goggles
- Base floor (when applicable)
- Acrylics
- Handles and control panel
- MP3 cable (when applicable)
- Headrest

Use only approved cleaner such as Lucasol One Step to clean and disinfect the tanning unit.

Long term consequences can exist if proper precaution is not taken.

- Over exposure should be avoided.
- Elderly people should not use this equipment without consulting their physician first.
- Children under the age of 18 cannot use these tanning devices.
- It is recommended that expectant mothers do not use these devices. While there are no clinical studies of negative effects of tanning with expectant mothers it is still not recommended.

This is a commercial grade tanning bed.



The Tanning Process

The tanning unit you have purchased is designed to concentrate optimal levels of UVA, in conjunction with very low percentages of UVB, on the outermost layers of the skin, so as to stimulate the production of Melanic pigment, which is slightly pink in its dormant state, these causes it to turn brown after excretion. The more Melanin cells present in the skin determines the amount of pigment that will be excreted and distributed, and therefore the extent of the tan.

UVA has a higher frequency of wavelength than UVB or UVC, and is the ray which is thought to promote the excretion of pigment from the hormone called "Melanin", which occurs naturally in the skin.

UVB is believed to be the catalyst, or kick-starter for the Melanin to begin producing pigment. It is also the ray which causes sunburn and wrinkling, so the skin can withstand only brief dosages at very small percentage levels to UVA.

UVC, present in natural sunlight, is mostly filtered out by the ozone layer in the upper atmosphere, and is extremely harmful to human skin, at any level of exposure.

In tanning beds, only small percentages of UVB to UVA are used to effect tanning - example: 95% UVA-to-5% UVB - whereby the individual tanner will be placed on an acceptable exposure schedule according to his or her skin type. There is no UVC emitted by tanning lamps.

Do not tan more than once every 48 hours. Depending on skin type, tanning sessions, each consisting of 10 to 12 individual sessions to create the base tan should be done continuously. However, no more than 3 of these treatments per week should occur. For more in depth detail on the tanning schedule see our exposure sticker on the unit and in this manual.

SKIN TYPE I - This individual burns easily and should NOT tan.

SKIN TYPE II - This individual burns easily and severely and should tan minimally.

SKIN TYPE III - This individual burns moderately and tans moderately.

SKIN TYPE IV - This individual burns minimally and tans well/ above average.

Tanning Sensitivity

Before using a tanning device always check with your doctor first.

***The following may increase skin sensitivity:**

- Perfumes and colognes containing furocoumarins.
- Compounds from natural products such as plants and fruits (their natural oils can sensitize the skin to sunlight).
- Food and fruits that contain photosensitizing agents: celery, carrots, lime, coriander, parsley, fennel, dill, buttercup, mustard and figs.

Before your tanning session

Check for any conditions mentioned in the manual that may prevent you from using the tanning equipment.

Make-up and cosmetics

Do not wear make-up when tanning. Clean skin absorbs the UV Light properly. Remove all make-up prior to tanning. Make-up clogs the pores in your face. The UV light from a tanning device re-opens these clogged pores. A wide variety of components and materials are found in make-up and cosmetics. These materials in conjunction with UV radiation can cause skin allergies so you should always remove make up prior to tanning.

Jewellery

Remove all jewellery prior to tanning, including piercings.

Hair and loose items

Any loose hair should be tied back using a hair tie. Any loose items on clothing should be secured.

Medications

Some medications increase the skin's sensitivity to UV light. The probability is especially high with antibiotics, sulphonamids, psychiatric drugs, tranquilizers, anti-diabetes treatments and diuretics. Sun creams which contain psorale or kumarin also may increase skin sensitivity. If you are unsure consult your doctor prior to using the equipment!

Contact Lenses

You do not need to remove your contact lenses prior to tanning but you must like all other users wear the protective goggles. The protective goggles protect your eyes against UV radiation. If you wish to have better protection you can contact your optician for exchange contact lenses with UV protection. These contacts are not just for tanning equipment but for UV light from the sun as well, consult your optician for more questions.

Showering and hydrating the skin

You cannot wash off a tan from a tanning device, unlike with spray tanning the the browning is in the skin and it will not wash off. It is recommended that you arrive for your session with clean and dry skin. Prior to your session you can apply tanning lotion. We recomend treating your skin to a moisturizing cream after showering after your session.



After the tanning session

Cleaning

All parts of the equipment that come in contact with the user must be cleaned and disinfected after each session. Cleaning is part of basic care that can be performed by qualified staff or service personnel.

Infections can be transferred through skin contact. The following items should be cleaned after each session:

- Goggles
- base plate
- acrylics
- handles
- control panel
- Mp3 components
- Only approved tanning bed cleaner should be used, such as Lucasol One step. Use of any incorrect tanning bed cleaner will void the warranty. Use only EPA registered quaternary ammonium germicidal based detergent solution. Always follow the product label for dilution instructions.

Cleaning Acrylics:

Do Not clean or rub with a dry cloth as it may cause scratches!

Non-approved cleaning agents should not be used, especially products including lysoform, ethyl alcohol or other liquids containing alcohol. **If used the warranty will be voided!**

ProSun® recommends the use of Lucasol One Step when cleaning acrylic sheets. Acrylics in tanning equipment are extremely porous and should not be cleaned/disinfected with non-approved products.

Acrylics should be cleaned after every use, even though they do not always come in direct contact with the user. If the user does touch the acrylic and those marks are left for a period of time, combined with the heat and light from the tanning lamps those marks can become permanent.

To clean the acrylics you should follow the instructions on the bottle. Never spray the solution directly onto the acrylic. Always spray a cloth and apply the cleaner, then use a clean dry cloth to make sure the acrylic is fully dried before the next session.



Operation of Equipment

Obligations of the business operator

- As the business operator you are responsible for informing the user of the risks of tanning.
- All danger and safety labels should be attached to the equipment and clearly visible to the user. You should not remove these labels at any time!
- No safety devices(i.e. temperature sensors) may be removed, deactivated or otherwise bypassed from the equipment, as it can cause safety issues and impair the proper functioning of the equipment.
- The equipment may only be used when in proper operating conditions.
- It is the business operators responsibility to ensure the tanning system is handled properly.

Staff Training

As a business operator you are required to train your personnel by ensuring that they have read and understood this user manual and all labeling on the equipment, and can properly operate the equipment and instruct them in the established legal and accident prevention regulations. Ensure that your staff is properly trained and understand how to use the equipment and that they observe all these instructions. This includes:

- Information regarding intended use and foreseeable misuse of the equipment.
- Safety Instructions
- Operating Instructions
- Cleaning/Disinfection and maintenance instructions.

Please make sure the instructions and any additional information from the manufacturer, such as manuals, are available to the staff at their workplace.

Regularly check that your staff is conscious of the safety rules and are aware of the risks of improper use of this equipment.

Ensure that equipment is properly cleaned/disinfected per the intervals set forth in the manual.

Ensure that your staff is providing the users with proper advice, in particular regarding the exposure times, operation of the equipment and possible risks for misuse.



How to operate the equipment

Prior to operating the equipment check that the unit has been cleaned and check for any damage to the acrylics.

No other people should be in the vicinity of the equipment when in use, especially no children under the age of 18. This device should be used by 1 person at the time.

Patient should remain upright while tanning, do not sit down.

Choosing the correct exposure time:

Make sure you check the exposure sticker on the front of the bed to match your skin type, not following the recommended exposure time may cause sunburn.

SKIN TYPE I - This individual burns easily and should NOT tan.

SKIN TYPE II - This individual burns easily and severely and should tan minimally.

SKIN TYPE III - This individual burns moderately and tans moderately.

SKIN TYPE IV - This individual burns minimally and tans well/ above average.

Normal Equipment Operation and software

Before turning on the equipment make sure you have proper warning signs at your location. We recommend permanently placing a Warning sign on the wall close to the tanning bed such as the one below:

WARNING

- UV Radiation can cause eye and skin damage as well as skin aging and possibly skin cancer. Ask the staff for further information.
- Wear protective eye goggles.
- Certain medicines or cosmetics can increase the sensitivity of the skin to UV radiation. If in doubt consult your physician.

Operating Modes:

There are 4 different operating modes for this equipment.

Standby Mode

The tanning bed is in an idle state, it is connected to the power but is currently not in use. The UV lamps in the unit are not turned on at this time. While in Standby mode you can change to Tanning mode by starting a session or go into service mode by entering into the parameters.

Tanning Mode

The tanning bed is in use and the UV lamps are on. The session time is counting down and can be stopped, paused or features can be changed in the control panel.

Cool down Mode

The tanning bed has finished the tanning session and now will start a mandatory cool down. During this time the cool down time will be displayed in the control panel and the buttons have no function if pressed. The bed must complete the mandatory cool down before being able to enter into any other operating mode.

Service Mode

In service mode the tanning bed parameters can be changed and the bed can be configured as needed.



Tanning Mode

The following description is for a unit that has all possible features, some of these features may not be available for your unit or market.



DANGER!

Excessive dose of UV radiation

Excessively prolonged tanning sessions may cause severe damage to skin and eyes.

- Never operate tanning device with a defective timer.
- Observe the tanning times given in the exposure sticker based on your skin type.

Starting the tanning session

The tanning session will automatically begin after the external timer delay time has expired. During the preset delay time the tanning session can be started by manually pressing the START button (2) on the control panel, thereby overriding the delay time.

If you do not override the delay time then you will have a few minutes to prepare yourself for the session.

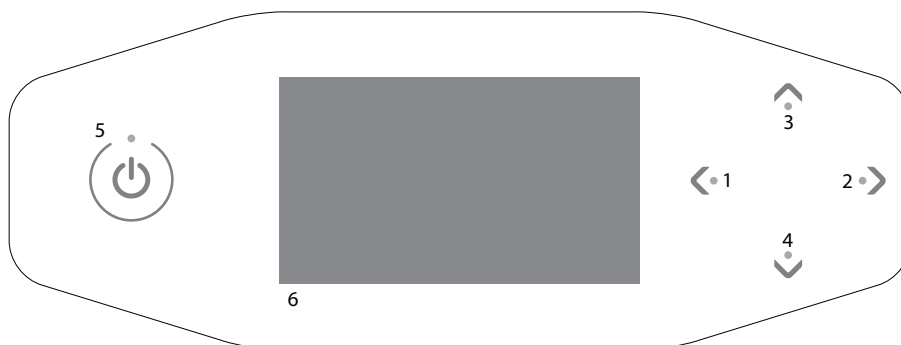
- Remove all clothes and jewelry
- Remove make-up and cosmetics
- Put on tanning lotions(if applicable)
- Remove glasses, contacts can be worn under goggles.
- Put on protective goggles.
- Close the tanning device
- Stand upright in the center of the tanning device facing the doors.

If you are ready prior to the delay time being open you can override the delay by hitting the START/STOP button.

Operation during the tanning session

During the tanning session the features can be used by pushing the buttons on the control panel. You can push the feature you wish to use (i.e. the fan button (5) followed by the increase button (3) or decrease button (4)).

Note: 20 seconds after your last input the control display screen will go back to the session time. You can change the features at any time by pushing the button of the feature you wish to activate.





Stopping the Tanning Session

If the time in the session runs out naturally then the unit will go into a 3 minute cool-down. However if you need to stop the tanning session prior to end of the session you can do so by hitting the START/STOP Button.

To pause the tanning session you can hit the START/STOP button once. Then to completely stop the tanning session prior to the end of our session time hit the START/STOP button twice and the unit will go into Cool-down mode.

Standby Mode

When the unit is in standby mode, you can change the decorative lighting on the tanning device.



Customer Concerns

Failure to use protective eyewear may result in severe burns or other eye injury. If discomfort develops, stop using the tanning equipment immediately and seek medical advice from your physician.

- Do not continue to use the tanning device if unexpected effects, such as itching, occur within 48 hours after the first tanning session. Seek medical advice immediately!
- The tanning unit must never be used if a facial filter is damaged or missing, or if the timer on the unit is defective.
- UV light from the equipment or the sun can cause injuries to the skin or eyes. This biological effect is dependent on the sensitivity of a users skin and on the type of UV light they are receiving. Users should follow the tanning exposure schedule on the unit and in the manual.
- As with natural sunlight, overexposure can cause eye and skin injury, sunburn or allergic reactions.
- If user is taking medications or has cosmetics on their skin, sensitivity may increase to UV light.
- A person with a history of skin problem should always consult a physician prior to tanning.

Always seek medical advice if in doubt!

Sometimes people using the tanning device will experience a slight reddening of the skin. This is usually in small patches and after the second or third tanning session. This redness can be accompanied by an itching sensation. This may just be a slight heat rash caused by the heat from the lamps within the device. It should be gone in about 24 hours. This feeling and reddening can be minimized or avoided by applying moisturizer to the affected area and/or used after the tanning session is complete.

- Always follow instructions and exposure schedules
- The time between the first two tanning sessions must be at least 24 hours.
- You may eventually reach a tanning plateau, at this point your skin will not get darker without edangering your health. You should never overexpose yourself with the tanning unit.
- Users should be properly informed on how to use the tanning equipment.



Storing the Device

Decommissioning your tanning unit

The equipment must be disconnected from the power in order to temporarily or permanently decommission it. You must follow legal disposal requirements when you are going to permanently dispose of your unit.

Storage

Store the equipment in a dry, frost free location with a stable temperature. Once the device has been unplugged from the power supply, allow it to completely cool before packaging it for storage. You can use plastic wrapping to protect against scratching. We recommend using moving blankets surrounded by plastic wrap.

Storage temperature can be between 5 °F (-15 °C) and 140 °F (+60 °C)

- Let equipment sit for at least 2 hours if range was outside of ambient temperature range.

Disposal

There are environmental regulations for disposal of lamps and batteries. UV Lamps contain fluorescent materials and other waste containing mercury. Contact your local health department, local garbage disposal or city authority to find out how to properly dispose of the equipment.



Packaging contains recyclable material.

Waste of electrical and electronic equipment must be disposed as unsorted municipal waste. It must be collected separately, and must be disposed as per local regulations. Contact ProSun International or an authorized representative for information concerning the decommissioning of your equipment.

Control Without an External Timer or Coins

Indicator Lights:


All indicator lights will be on the display of the unit and will show green when ready to use or for selection purposes.

The machine is set up for standard use with an external timer or a coinbox. If the machine must function without the external timer or coinbox, i.e. with the internal timer, the required tanning time will have to be adjusted according to the following procedure.

Coin-operated mode without remote start



The machine will be started automatically if there is no 'remote start' present on the external timer or coin unit. The 'remote start' can be configured by your dealer.

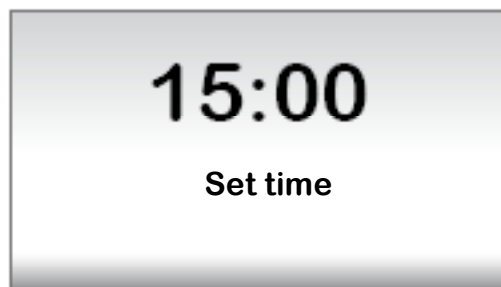

Press  1x during tanning to put the machine in pause mode. The lamps are switched off. The body cooling remains on (maximum 4 minutes). Xsens (optional) and Qsens (optional) are paused.




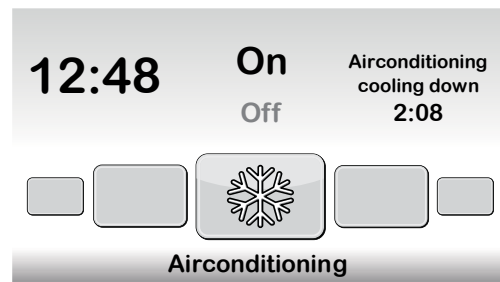


Air conditioning (optional)

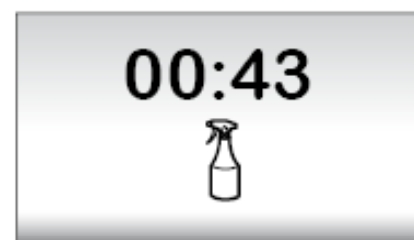
MAINTENANCE

Cleaning

The tanning appliance is equipped with a touch panel control. To prevent accidental operation of the machine during cleaning, you can temporarily switch off the control. It is also recommended that you temporarily switch off the control before you open the acrylic screen canopy.

Hold and for 5 seconds.

The display shows the remaining time + 'Cleaning'. During this period the display cannot be operated.
The time you have to clean the machine can be changed. The standard cleaning time is 1 minute.



Cleaning the air conditioning (option)

Clean the air conditioning as explained in the instructions that accompanied your air conditioning unit.
You must reset the service date after cleaning.

To reset the service date while a fault message is displayed, press to enter the 'Quick status menu'. From the standby screen, hold the , and buttons for 5 seconds to enter the 'Quick status menu'.

Navigate to 'Airco service date' and press .
Enter the PIN code and press .

The airco service date is increased by 6 months.

Replacing the Qsens (option) liquid jug

Never refill your Qsens liquid jug with regular tap water or any other liquid. Replace with an original Hapro Qsens liquid jug. Remember to order the Qsens liquid jugs in time.
Before Qsens can be used for the first time or after replacement of the liquid jug, the system must be bled of air.

Hold the , and buttons for 10 seconds.
Enter the PIN code; it is set to 0000 by default. Press to confirm. You are now in the parameter menu.

Navigate to '09 - Qsens' and press .
Navigate to '03 - Qsens initialization' and press .
Press to start the initialization.
Wait until the Qsens nozzles produce a fine mist of water.
Press to stop the initialization.
Press to exit the parameter menu. Your Qsens set is now ready for use.



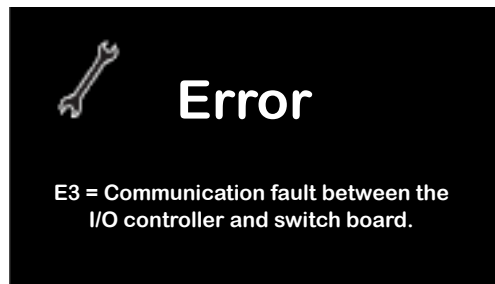


Error messages

Malfunction

When a malfunction occurs, the buttons , , and flash when the machine is in standby. The machine also produces 3 rapid beeps once every minute. Press all four of the buttons at the same time to see which fault or faults have occurred.

If a critical fault occurs, the malfunction screen appears automatically. The text 'Malfunction' appears at the top of the screen, and the fault code and an explanation appear at the bottom. Use the and buttons to view the various fault messages. For faults E18, E19, E20 and E21 you can exit the malfunction screen with the or button.



Critical errors

E1 = Internal timer has a defect
E2 = Fan in bottom tray has a defect
E3 = Communication error between relay and switch part
E6 = Unknown phase
E7 = Relay failure
E9 = Maximum temperature bench
E10 = Maximum temperature canopy
E11 = Communication error with fan board

Errors

E18 = Communication error with bench temperature sensor
E19 = Communication error with canopy temperature sensor
E20 = Air conditioning reservoir full
E21 = Clean air conditioning

NOTE:

When one of the above-mentioned critical faults appears on the display, you should no longer use the tanning appliance and the plug should be removed from the mains outlet. Contact your dealer.

If one of the other faults occurs, the machine will still function, but not all the functions will be fully available. During fault E18 and E19 the machine cooling will run at maximum throughout the entire session. To correct this, contact your dealer.

E20: Air conditioning reservoir full

Check whether the reservoir for the air conditioning is full. If the reservoir is full, you should empty the reservoir (see section 'Emptying air conditioning reservoir' in this manual). The fault message disappears after several seconds. If the fault message does not disappear, contact your dealer.

E21: Cleaning the air conditioning

The air conditioning must be thoroughly cleaned every 6 months. If the air conditioning has not been cleaned within the past 6 months, fault message 'E21: Clean the air conditioning' will appear. You must thoroughly clean the air conditioning. After it has been cleaned, you must reset the 'Airco service date'. For more information, consult the 'Cleaning' section in this manual.



NOTE - When one of the above mentioned errors appears on the display, you should no longer use the tanning unit and you should disconnected it from the mains outlet or plug. Contact ProSun immediately.



Care and Maintenance

The Care and Maintenance in this section provides information on how to properly care for your equipment after each use and during the lifespan of the unit. It will help provide you with basic troubleshooting and maintenance questions. If your tanning bed fails to operate properly, please review the following steps before calling for service.

THE TANNING BED YOU PURCHASED CONTAINS VOLTAGES WHICH ARE POTENTIALLY HAZARDOUS. IN THE FOLLOWING PAGES YOU WILL RECEIVE A CLEAR DESCRIPTION OF WHAT CARE AND MAINTENANCE CAN BE DONE BY A NON-SKILLED PERSON THAT HAS READ AND UNDERSTOOD THE MANUAL AND WHICH REPAIRS AND MAINTENANCES SHOULD BE PERFORMED BY CERTIFIED TECHNICIANS.

FOR YOUR TANNING BED:

Safe and continuous operation of your tanning bed depends partially on the care taken by users. Please observe the following precautions when tanning bed is in use.

- Do not allow sharp object in the bed while in use. Avoid having the acrylic sheets coming in contact with sharp edges or objects.
- Do not allow liquid or any foreign objects to get inside the unit.
- Ensure the back side of the unit is at least 8 to 12 inches from the wall.
- The room in which the unit is located must be well ventilated.
- Make sure the unit never comes in contact with water while connected to power.
- Do not turn the Machine on and off frequently within the space of 3 minutes.
- When replacing or cleaning facial lamps, both facial lenses and the bulbs should be cleaned with alcohol, keeping them free of smudges and finger prints. (only applies to equipment with facial lamps).



DANGER - High Voltage !

You can be killed or injured by an electric shock!

During maintenance and service work there is a risk that you can touch live parts and could receive a fatal shock. When performing basic care maintenance and before a certified technician performs maintenance work they should make sure:

- The device is disconnected from the power supply.
- The device is not in use.
- Do not reach behind the cover plates and do not open the unit while it is switched on.
- Refit and safety devices after work has been completed.

If service or maintenance work is going to be performed on the equipment then they must be deenergized. Meaning that all live cables must be switched off.

Switching off the device alone is not enough, certain points may still be energized. Therefore, switch off fuses before performing any work, if possible also remove these fuses before starting.

Accidental reactivation can result in serious accidents. Immediately after deenergizing the equipment, secure all switches or fuses used for deenergizing against being switched on again.

Basic Care Maintenance

Basic Care Maintenance and service of your equipment play a major role in maintaining the units performance and appearance over the period of its useful life. Compliance at the intervals specified for your unit are absolutely necessary to ensure the proper operation of the equipment. The table below is a preventative care table that can be done by any unskilled person, if any service outside of this table is needed please contact ProSun immediately and this should only be done by a certified technician.

The equipment should be routinely serviced and maintained by a ProSun certified technician.



WARNING!

Injuries and damage due to improper maintenance!

If the maintenance intervals of the UV lamps are not followed or if incompatible UV lamps are installed, harmful UVB radiation may increase. Sunburn and other skin damage may result.

Improper maintenance can cause the unit to become inoperable.

Always comply with the maintenance schedule supplied in this manual and follow cleaning/disinfecting instructions.

NEVER use this unit if the blue filter glass is missing, cracked or otherwise damaged. SEVERE INJURY may result within seconds. (only applies to equipment with facial lamps)

For thorough cleaning and disinfection, the product you are using has to remain in contact with the surface that is being cleaned and disinfected for a specific amount of time, as mentioned on the instructions of the product. The specific amount of time will depend on the type of cleaner/disinfectant that you are using. Follow the directions on the product.



The below basic maintenance can be done by an unskilled person.

Cleaning Plastic Surfaces:

For cleaning plastic surfaces we recommend using regular soap and warm water. Never use an aggressive cleaning agent that contains alcohol or essential oils. Using inappropriate cleaners may cause permanent damage not covered by warranty. Remove all jewelry and loose items before cleaning.

Cleaning Lamps:

Low pressure lamps can be cleaned with a damp cloth (without any additional cleaning agents). Dust lamps with a dry soft cloth - do not use cleaning fluid or alcohol.

Cleaning the machine

Always disconnect the main power from the unit before attempting to clean or repair it. Dust the lamps with a dry cloth - do not use cleaning fluid or alcohol. We recommend using Lucasol as the cleaning product. The acrylics should be taken out at least once every week of operation and cleaned thoroughly with a non-alcoholic disinfectant glass or surface cleaner. If alcohol is used, the acrylic may fade, crack, or break altogether. Failure to use anything other than an approved cleaning material on the acrylic will result in poor UV-transmission, and could eventually cause injury to the person using the machine. Use a vacuum cleaner with a dust nozzle to clean around the ballast racks and throughout the interior portions of the base, top deck, and bench.

Maintenance by skilled persons:

ProSun recommends having an annual inspection by a certified technician to review connections, check for loose wiring, check the power cords and review all other high voltage components. At this time the certified technician can dust all electronic components.

Longevity of the acrylic sheets

The acrylic sheets used in this machine should be changed between 1200 and 1500 hours of operation. If not, UV-transmission could be greatly reduced.

The acrylics for the unit are produced of an acrylic glass developed specifically for tanning sessions. The use of other acrylic material can cause serious injury due to the incorrect passing of UV radiation. The acrylics used in your equipment have a particularly high UV permeability and resistance, ensuring that the user receives the correct UV radiation when using the exposure schedule properly.

Longevity of the lamps

Most lamps will display up to 120% of rated output during the first 50 hours of illumination. As such, exposure schedules should be reduced by 20%, or sunburning may occur. After the initial 50 hours, the lamps will run at 100% of their rated output and gradually go down from there, until about 800 hours, where upon the lamps should be replaced.

Disposal of Lamps

Tanning lamps contain fluorescent materials and other waste that contain mercury. Certain areas in the US and Canada have specific regulations on disposal of these wastes, you can contact your health department, local garbage disposal company or city authority to find out where and how to properly dispose of them. You should retain proof of proper lamp disposal.

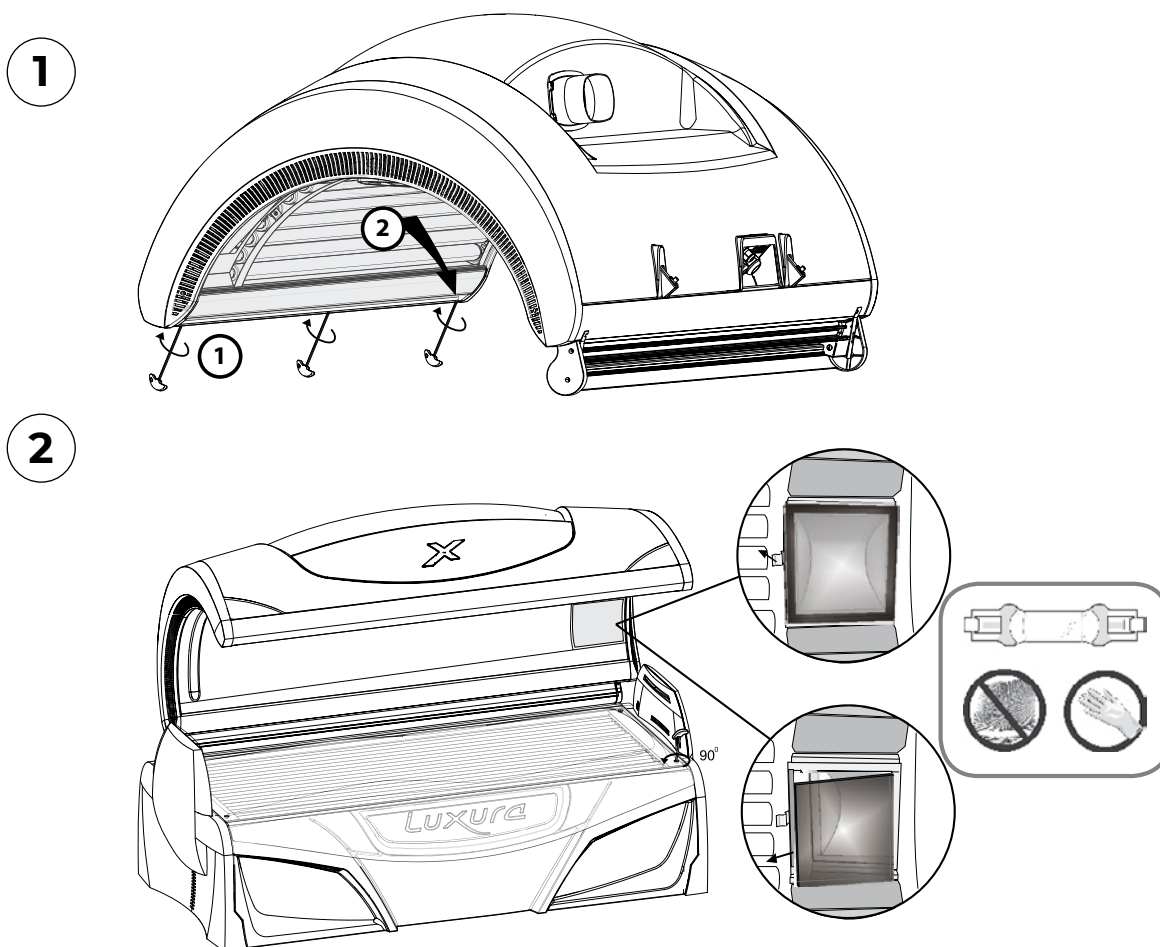
Lamp replacement:

Holding the lamp at both ends, turn it counter-clockwise until the bi-pins can slide easily out of the lamp holder socket, and slowly take it out of the unit. Replace the lamp in just the opposite manner, making sure that the labeling on the lamp itself is pointed outward, and that you have heard 2 clicks to ensure the lamps are securely fastened.



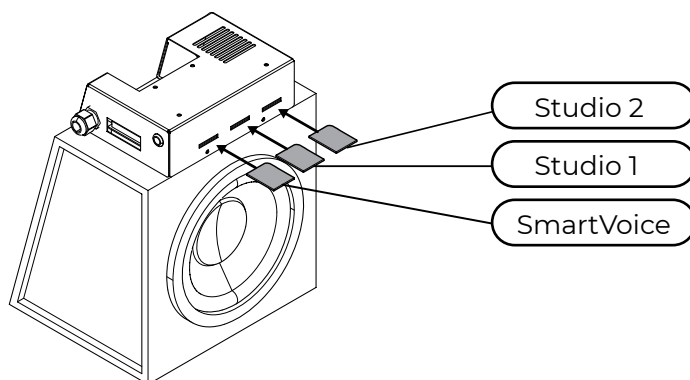

Warranty

ProSun Commercial Tanning Bed Warranty LIMITED WARRANTY Revised September 2020

Warranty Period:

Provided it is still owned and operated by the original owner, PROSUN warrants all equipment manufactured or imported by it to be free from defects in material under normal use and service. Warranty Periods as specified below are from the date of delivery to the location. The warranty is non-transferable and is only valid for the original purchaser of the equipment.

What is covered:

During the Limited Warranty period as specified below, PROSUN will be repair or replace any defective system or components found to be defective, at PROSUN's sole discretion. Prior to making any repairs, the owner must provide PROSUN with information requested and perform basic troubleshooting. PROSUN will review the problem and provide disposition of parts and guidance to the authorized technicians performing the adjustments or repairs. Any repairs attempted or damage done as a result of such attempts, prior to reporting the problem for disposition and guidance by PROSUN customer service, shall void the limited warranty.

The cost to the Purchaser is based on the proration of the warranty on the defective system or components and labor. The limited warranty is as follows:

- 10 year warranty on steel frame
- 12 Months on Electronic Components.
- 90 days on Labor.

General Warranty Terms and Limitations:

- The Warranty Period is based on the date of delivery.
- The Limited Warranty will be null and void if equipment has been damaged and not reported and repaired or maintenance/service has not been performed as defined in the User Manual.
- Equipment must be owned by the original owner, in original installed location. It may not have been physically moved from its original installed location unless otherwise authorized by PROSUN and removal and reinstallation performed by PROSUN certified technicians. Failure to do so will void the warranty.
- Outside of the normal maintenance recommended in the User Manual, any work performed on the equipment by a non-authorized technician without the express consent of PROSUN will void the warranty.
- All warranted parts will be sent out with Ground shipping costs, expedited shipping will have an additional charge to the customer.
- Replacement parts purchased after the original warranty period are extended a 90-day warranty only if those parts have been purchased from PROSUN and installed per PROSUN's instructions and approval.

Note: Payment in full is required prior to shipping replacement parts outside the warranty period or not included in the warranty. Any product being returned to PROSUN for repair, replacement or return must be adequately packaged to prevent freight damage and must be shipped via traceable methods unless otherwise authorized in writing by PROSUN.

What is not covered:

- Labor to replace warranted parts or make repairs outside of the labor warranty period, or to perform annual maintenance.
- Any parts affected by discoloration or use of non-approved cleaners
- Damage caused by use for anything but its intended use, mishandling, abuse, negligence, external trauma due to overloading or not maintaining the equipment properly.
- Cosmetic damage, whether intended or due to wear and use.
- Damage due to improper electrical installation or connection including overpower, under power, and incorrect service connection - including any failure to the external voltage transformer (i.e. Buckboosters)
- Cracked or broken cover plates, end caps and sidebars
- Any failure of the external timing system (example: T-Max, FST timers and timer system components).
- Any damage caused by the failure of any supporting hardware not supplied by PROSUN.
- Acrylic sheets, starters (igniters), lamps, blue and clear filter glass.
- Tanning units, parts or components damaged in transit where PROSUN'S damaged goods policy is not followed by purchaser or purchaser's designee.



THIS WARRANTY DOES NOT APPLY TO ANY FAILURE OF PRODUCT DUE TO ALTERATIONS, MODIFICATIONS, MISUSE, ABUSE, NEGLIGENCE, ACT OF GOD, ACCIDENT, IMPROPER MAINTENANCE (INCLUDING LACK OF ANNUAL MAINTENANCE) OR INSTALLATION, USE OF PARTS NOT SUPPLIED BY PROSUN, FAILURE TO OPERATE AND USE THE PRODUCT IN ACCORDANCE WITH THE INSTRUCTIONS PROVIDED IN THE OWNER'S MANUAL SUPPLIED WITH THE PRODUCT OR FAILURE TO OTHERWISE MEET MANUFACTURER'S SPECIFICATIONS, OR IF THE SERIAL NUMBER HAS BEEN REMOVED, ALTERED OR DEFACED. Procedure for Requesting Warranty Work and Parts:

In the event of an issue that is covered under this limited warranty agreement, the customer must first contact PROSUN. PROSUN Customer Service will initiate a service ticket and issue you a Warranty/Incident claim number. The customer must work with ProSun by phone or email to provide all necessary information on the issue with the equipment and perform basic troubleshooting tasks.

1. If your equipment has a manufacturer's defect within the first 90 days, the necessary parts will be sent to you via expedited shipping options. After being given a claim number by customer service, you will be sent and must sign our warranty documentation and return it to PROSUN prior to the parts being sent out, unless otherwise authorized by a ProSun representative.
2. A return shipping label will be provided. You will need to return the original or any unused parts to PROSUN unless otherwise advised in writing. If the original defective parts are not returned within 30 days, you will be responsible for the purchase charges for the parts. If unpaid, your account will be placed on hold until the issue has been resolved.
3. Any warranty parts needed outside of 90 day warranty period will require payment up front, unless otherwise authorized by a ProSun representative. A return label will be provided with your warranty parts and a full credit will be provided to your payment method within 10 business days of receiving the original or returned unused parts. If parts are not returned within 90 days or have been damaged, a credit will not be issued or may be subject to a restocking fee.
4. Depending on the labor warranty as stated in this agreement, PROSUN will help the customer by phone to replace the component or will schedule a technician to perform the service work.

Right to Modify:

PROSUN reserves the right to make changes or improvements to its products without incurring any obligations to similarly alter products which have been previously purchased.

Exclusivity of Warranty:

This warranty is the only warranty made by PROSUN and may only be modified or amended by a written instrument signed by a duly authorized officer of PROSUN. PROSUN's sole and exclusive liability and Purchaser's sole and exclusive remedy under this warranty shall be, at PROSUN's discretion, to repair or replace, to the extent available on a prorated basis, any such defective Products. These remedies are available only if PROSUN's examination of such Products discloses to PROSUN's satisfaction that such defects actually exist and were not caused by Purchaser's misuse, abuse, neglect, improper installation, maintenance or testing, alterations or modifications, failure to meet manufacturer's specifications or any other cause beyond the range of normal usage, or by accident, fire or other hazard. Repair or replacement of a part does not extend the warranty period or extend the prorated value of a part or product beyond the initial limited warranty periods as specified and set forth above.
